

Instructions and directions of online counselling for Internship of FMGs **(Read carefully the following instructions before filling the application)**


1. The applications are accepted only on prorata basis, based on total number of seats available in State Medical Colleges/ Institutions of the State.
2. Rajasthan Medical Council has the right to reject any application in case it doesn't fulfil the criteria.
3. Online counselling will be conducted only in single and final round. Candidates who are selected in counselling will join in allotted Medical College/ Institution upto scheduled date positively.
4. Rajasthan Medical Council will scrutinise all the applications and shall prepare two Merit lists according to following criteria and the same will be published on the website of Rajasthan Medical Council as per prescribed schedule:-

CRITERIA FOR PREPARING MERIT LIST

- Merit list will be prepared on the basis of score/marks obtained in the National Board of Examination (NBE).
 - **Merit List 1:** Candidates who are resident of Rajasthan (Passport Domicile Certificate as Address proof) based on NBE score and have completed their (10+2) from CBSE/Rajasthan Board of Secondary Education or Equivalent Board in Rajasthan.
 - **Merit List 2:** Candidates who are resident of other states. Merit list will be prepared based on NBE score/marks obtained by the candidate.
 - In case of more than one candidate with same score, merit will be determined on the basis of following criteria:-
 - a. Candidate who has secured higher percentage in subjects of Physics, Chemistry, Biology (PCB) marks in (10+2) examinations.
 - b. Candidate who has secured higher percentage in subject of Biology marks in 10+2 examinations.
 - c. Candidate who is older as per date of birth.
 - d. The seats will be first allotted to candidates according to Merit List 1 & then Merit List 2 respectively.
5. The candidates according to Merit Lists are eligible to apply online for Provisional Registration with Rajasthan Medical Council after joining the internship in allotted Medical College/ Institution.

6. The selected candidates have to join the internship programme immediately upto scheduled date positively from the date when list is uploaded on official website of Rajasthan Medical Council.
7. The candidate has to submit a affidavit stating clearly wether his/her studies were online/offline/partially online/partially offline, affidavit should not be less than Notary Public level (Annexure-I).
8. Candidate will attach all required documents (scanned copy) which would be confirmed by their passport at allotted Medical College with online application form and at the time of joining the internship and he/she will get them verified with original documents in the office of Principal of concerned Medical Colleges.
9. During the scrutny of application or at the time of internship joining, if any information/document found to be fractacious, the application form can be rejected and for that candidate will be responsible solely.
10. Candidates who are already doing internship through previous counselling conducted by this council, are not eligible for this online counselling. If any candidate applies again in this counselling, their application would be rejected and for this he/she will be liable/responsible.
11. As per 129th GBM decision dated 20th June, 2023 internship counselling application fee of Rs. 5000/= (Rupees five thousand only) + 18% GST will be paid to council by FMG intern students.
12. As per NMC Circular dated 9th May, 2023, it is clarified that the amount of stipent to be paid to the FMG interns is to be decided/fixed by the State authorities under which the medical college/institution is located.
13. The period of internship would be according to instructions issued by NMC and Public Notice issued by this Council vide No. 6112 dated 03-04-2024 and 6255 dated 23-04-2024.
14. **Internship in the Government Medical Colleges are non stipendry, for the Private Medical Colleges and institutions, they may decide as per their institute policy. The candidates have to furnish a affidavit stating that they will not demand any kind of stipend while doing internship in Govt. Medical Colleges.**
