PUBLIC NOTICE **RULES FOR FOREIGN MEDICAL GRADUATES FOR FMGL** **REGULATION 2021**

1. The Foreign Medical Graduate who have already applied with Rajasthan Medical Council for provisional registration and are willing to do internship in Rajasthan, the seats will be allotted to these candidate as per FMGL Regulation, 2021.
2. The foreign Medical Graduate are requested to apply online to be considered for Internship Training at medical colleges in Rajasthan and the application are accepted only on prorata basis, based on total no of seats available in Medical Colleges in Rajasthan.
3. Rajasthan Medical Council has the right to reject any application in case it doesn't fulfil the criteria.
4. Rajasthan Medical Council will scrutinise all the applications and shall prepare two Merit lists considering FMGL Regulations 2021 and the same will be published on the website of Rajasthan Medical Council.

CRITERIA FOR PREPARING MERIT LIST

Two separate lists will be published according to following criteria:
Merit List 1 Candidates who are resident of Rajasthan (Passport/Domicile Certificate as Address proof) and have completed their(10+2) from CBSE, Rajasthan or Equivalent Board in Rajasthan.

Merit List 2 Candidates who are resident of other states.

Merit list will be prepared based on NBE score of Screening Test Result obtained by the candidate and in case more than one candidate with same score, merit will be determined on the basis of following criteria:-

- a. Candidate who has secured higher percentage in subjects of Physics, Chemistry, Biology (PCB) marks in (10+2) examinations.
 - b. Candidate who has secured higher percentage in subject of Biology marks in 10+2 examinations
 - c. Candidate who is older.
 - d. The seats will be first allotted to candidates according to Merit List & Merit List 2 respectively.
5. The candidates who make up the Merit List will be eligible to apply for provisional registration with Rajasthan Medical Council online; 7 days from publication of such list. (No need to apply again in case the candidates have applied or provisionally registered with Rajasthan Medical Council.)
 6. Final List of successful candidates for both categories candidates who have already applied for provisional registration & candidates who wish to apply in RMC detailing the respective college allotted for undergoing internship will be published on Rajasthan Medical Council website.
 7. The selected candidates have to join the internship programme immediately but not later than 7 days from the date on which final list is uploaded on official website of Rajasthan Medical Council and if candidate is not able to join the allotted medical college/institution within 7 days, the seat will be considered vacant and will be allotted to next eligible candidates as per Merit List, who meet the necessary criteria.
 8. Stand alone PG Institutes imparting DNB training under DNB-PDCET and non-teaching hospitals are not entitled to conduct Compulsory Rotatory Medical Internship after the publication of the Public Notice from National Medical Commission Dated 21st September, 2022
 9. The amount of stipend to be paid to the interns is to be decided/fixed by the appropriate authority Directorate of Medical Education and is solely at the discretion of the concerned authorities under which the medical college/institute is located and Rajasthan Medical Council does not bear any liability in this regard.
 10. When you join Internship in allotted college candidate should immediately intimate to Rajasthan Medical Council in person.
 11. The candidate has to give an affidavit stating clearly whether his/her studies were online/offline/partially online/partially offline affidavit not less than Oath commissioner level.
